### **APPLICANT PRE-REQUISITE CRITERIA**



### **Technical Criteria**

- Registered member-based producer organisation; or
- Registered company with at least one staff member in the field of production, processing, marketing, domestic/export/wholesale/retail of agricultural produces/products, digital and technology enthusiasts; or
- Registered company with at least one staff member working in service provisions & other fields.
- Demonstrated capacity to execute and lead projects
- Existing engagement or planned transition as part of the project to sustainable agricultural practices/ products
- Willingness to make fund matching contribution equivalent to proposal budget-either monetary or in-kind contribution
- Funding is only available in selected four countries: Cambodia, Lao PDR, Myanmar and Viet Nam
- In Vietnam, AIF only supports innovative ideas related to litchee value chain in Bac Giang and mango value chain in Son La, which are applying VietGAP standards

### **Social & Environmental Responsibility**

- Demonstrated commitment to sustainable and inclusive business practices
- Willingness to work for mutual benefits in the value chain, especially with regards to small-holder farmers, producer organizations, youth and women
- Approaches conducive to reduce GHG emissions and/or support resilience and adaptation to climate change

### **Potential for impact**

Proposals should document how they can positively impact (directly or indirectly) resilience and sustainability in the value chain in one or more countries of focus



### **Innovation**

Proposals should put forward new innovative ideas for systems and products that are yet to be implemented in the area, country, or region



### Inclusiveness

Proposals preferably demonstrate how they can engage and benefit youth and women in the community



### Replicability

Proposals preferably provide sufficient level of replicability in other areas, country or region



### **Scalability**

Proposals preferably provide a vision for future scaling of products and systems developed within the Fund
