PPP TASK FORCE ON LIVESTOCKS

1. Established on 22/4/2019 under the Decision No. 1322/QĐ/BNN-HTQT
2. Members:
 - Public sector (Co-Chair): Livestock Production Department and National Agriculture Extension Center
 - Private sector: Công ty Cổ phần chăn nuôi CP Việt Nam, Tập đoàn Hùng Nhon và Tập đoàn De Hues
3. Bao gồm 04 tiểu nhóm: Lợn (heo), Bò sữa, Gia cầm và Thức ăn Chăn nuôi

ROLES

1. Monitoring the status of livestock value chain development
2. Advise and recommend to the Ministry in policy making process
3. Mobilize and connect partners to build and implement safe livestock development programs / projects, improve product quality and income for people.
4. Disseminate knowledge, improve the capacity of actors in the chain.
5. Provision and sharing of information, trade promotion and public-private cooperation.

OBJECTIVES

1. Establishing models of production linkage, product consumption along with the value chains
2. Improve the quality of livestock products and ensure food safety, increase competitiveness compared to imported products
3. Improve production capacity in connection with product consumption, improve income for livestock establishments.
4. Develop models, training, propaganda information on PPP in Livestock sector
